

Threshold's BIG Swindon SleepOut 2022 Terms & Conditions

By registering for our '**BIG Swindon SleepOut**' you are agreeing to comply with the following terms and conditions:

1. You agree that you are physically capable to be taking part in the event and agree to be solely responsible for your actions and the protective measures you put in place to ensure your safety and that of other participants in your bubble. You agree that Threshold is not responsible for any injuries or illness that you may suffer as a result of your participation in this event. Threshold staff and volunteers will provide security on the night and a First Aider will be on hand at our venue.
2. You accept that should any medical or physical condition arise prior to the event that is likely to affect your ability to take part by staying up or sleeping out that you are responsible for adapting your means of participation as appropriate to changes in your personal circumstances. You understand that, if you cannot take part in the event as you envisaged, that your sponsorship is cause related and not solely dependent upon your active participation alone and therefore you agree that any monies raised by you will be donated to Threshold and will not be refunded.
3. You acknowledge that any fundraising activities you organise in relation to the 'BIG SleepOut' are as an independent 'Friend and Supporter' of Threshold. It is your responsibility to refer to raising money 'in aid of Threshold' in your social media postings (rather than 'on behalf of').
4. You agree to act lawfully when fundraising in aid of Threshold and to comply with any government instructions and Public Health England (PHE) guidance in relation to social distancing guidelines during your fundraising activities.
5. You agree that it is your responsibility to organise all aspects of any fundraising activity undertaken by you and that you will be responsible for any costs, tax, insurances or expenses incurred or arising in connection with your fundraising activities. Basic, straightforward sponsorship obtained from your friends, family and colleagues should incur no costs, taxes or other expenses – so keep it simple, ask those close to you to consider a donation.

6. When producing any materials or making social media posts using the Threshold logo, you must seek approval from our Special Events Coordinator and adhere to the in-house style guidelines (which can be provided on request). Our Charity number must also be included (UK registered charity No. 1017599).

7. You agree to send all funds collected or raised to Threshold within 1 month after the event date, at the latest. You must not deduct from your fundraising any costs incurred by you.

8. By providing your personal information when you sign up to fundraise for Threshold, you understand that Threshold will contact you via phone, email, social media and any other legitimate means in order to communicate relevant event information in the lead up to, throughout, and post your participation in this event.

9. We respect and protect your personal information and you agree that your personal information may be used for the purpose of sending communications to you where you have confirmed that you would like to receive further information about the charity's work when signing up to fundraise for Threshold. All personal data held by us will be handled in accordance with applicable GDPR and other privacy legislation.

10. You acknowledge that you are fully responsible for your participation in the event and Threshold does not accept responsibility or liability for any loss or damage arising to you from your participation in the event. You accept that any risks arising from your fundraising activities are your responsibility, including liability for injury or loss that may occur to you, helpers or guests within your 'support bubble'. You will take all reasonable precautions to protect the health and safety of all those participating in, involved with or attending your activity.

11. You will comply with any applicable laws and regulations relating to your fundraising activity, including obtaining any necessary licences, consents or permissions.

12. You acknowledge and accept that Threshold's insurance policy does not cover your fundraising activities.

13. You will not do anything that threatens Threshold's reputation or misuse its good name. If it is deemed that you do, Threshold has the right to ask you to stop your fundraising activities immediately.
